21 May 2024	SignatureSuper SignatureSuper – Term Pension SignatureSuper – Allocated Pension	AMP recently received guidance from the Australian Taxation Office (ATO), that from 1 July 2024 Super Funds (and IDPS operators) will no longer be able to claim a Reduced Input Tax Credit (RITC) on behalf of members for Advice Fees.	SENs have been issued to all SignatureSuper members with an active advice fee arrangement. The notice confirms that from 1 July 2024 AMP will no longer be able to apply a RITC discount on the GST of their advice fees.
20 February 2024	SignatureSuper SignatureSuper – Term Pension SignatureSuper – Allocated Pension	Trustee Expense Recovery notification to members regarding implementation of 1 Apr 24 Trustee Expense Recovery, changes to Insurance Service Expense and implementation of 1 Dec 24 (at the earliest) Trustee Fee	Changes impact all SignatureSuper members and are effective 1 April 2024 or 1 December 2024 (respectively).
29 January to 29 February 2024	SignatureSuper	Transition to new default insurer (from RLA to TAL). Changes to insurance design, T&Cs, and pricing.	Provide 30 days' notice to impacted members to consider the transfer/insurance change to be made effective on 1 April 2024.
23 May 2023	SignatureSuper	Notification to ~300 members regarding the soft close of 2, 3 and 5 year Term deposits and 1 year with monthly interest.	Provide 30 days' notice to impacted members.
