### Investment objective

It also aims to deliver a return greater than its performance benchmark (market indices weighted by the Fund's long-term benchmark) on a rolling three-year basis. The Fund may be suitable for investors seeking to invest in a diversified fund with a bias towards growth assets. The Fund aims to pay distributions half-yearly. ### How we manage your money


The Fund invests in a diversified range of asset classes, with a bias towards growth assets. It employs a combination of active and passive investment management.
